Notice is hereby given pursuant to V.T.C.A. Government Code, Chapter 551, that the Board of Directors of Ponder Farms Municipal Utility District of Denton County (the "District") will meet in **special** session, open to the public, at **12:00 p.m.**, on **Friday, February 27, 2026 at the offices of Coats Rose, P.C., 16000 N. Dallas Parkway, Suite 350, Dallas, Texas 75248**, at which meeting the following items will be considered and acted on:

1. Hear from the public;
2. Consider approving minutes of the meeting of February 6, 2026;
3. Hear Bookkeeper's Report and authorize payment of the bills;
4. Consider approving proposed budget for the fiscal year ending February 28, 2027.
5. Hear Developer/Landowner's Report;
6. Hear Engineer's Report and consider taking any action requested by Engineer, including:
  - (a) authorize Engineer to proceed with the design of District facilities;
  - (b) approve plans and specifications of District facilities;
  - (c) authorize Engineer to advertise for bids for District projects;
  - (d) authorize construction contracts and related items;
  - (e) approve report, pay estimates, and change orders for construction projects in progress in the District;
7. Hear Financial Advisor's Report and authorize any necessary action; and
8. Hear Attorney's Report and consider taking any action required, including:
  - (a) consider approval of a Resolution Approving Interlocal Agreement between the City of Denton and the District for the Installation of a Thirty Inch (30") Water Line;
  - (b) consider approval of Agreement Regarding Offsite Waterline by and between the District and D.R. Horton – Texas, Ltd.;
  - (c) consider ratifying prior approval of Utility Easement by and between the District and The Lively Place, LP;
  - (d) consider approval of an Interlocal Cooperation Agreement for Property Tax Assessment and Collection by and between the District and Denton County, Texas;
  - (e) consider approval of Denton County Tax Office Authorization Agreement for Direct Deposit;
  - (f) acceptance of a Certificate Regarding Unopposed Candidates;
  - (g) approval of an Order Cancelling Directors Election and Declaring Unopposed Candidates Elected to Office.


