Notice is hereby given that, pursuant to V.T.C.A. Government Code, Chapter 551, the Board of Directors of **Denton County Municipal Utility District No. 5** will meet in **regular** session, open to the public, at **11:00 a.m.**, on **Tuesday, May 12, 2026**, at **11000 Frisco Street, Suite 400, Frisco, Texas 75033**, at which meeting the following items will be considered and acted on:

1. Hear from Public (public session limited to 15 minutes; each speaker limited to 3 minutes);
2. Consider accepting Oaths of Office and Statements of Officers from Directors Elect;
3. Consider approving and issuing Certificates of Election to Directors-Elect;
4. Consider reconstituting Board of Directors;
5. Consider authorizing preparation and filing of Amended District Registration Form
6. Hear Public Safety Reports (Police/Fire/EMS) and take action thereon;
7. Consider approving Minutes of April 14, 2026;
8. Hear Bookkeeper's Report, and take any action thereon, including:
  - (a) consider approving payment of bills;
  - (b) consider approving investment report and
  - (c) consider approving Depository Pledge Agreement with Central Bank;
9. Hear Engineer's Report and take any action thereon, including:
  - (a) consider authorizing Engineer to proceed with the design of District facilities;
  - (b) consider approving plans and specifications of District facilities;
  - (c) consider authorizing Engineer to advertise for bids for District projects;
  - (d) consider authorizing construction contracts and related items; and
  - (e) consider approving report, pay estimates and change orders for construction projects in progress in the District;
8. Hear Attorney's Report and take any action thereon, including:
  - (a) consider approving Resolution Evidencing Annual Review of Investment Policy;
  - (b) review Arbitrage Report and take any action thereon; and
  - (c) discuss required Cyber Security training.

Government Code §551, the Board of Directors may convene in closed session in relation to any agenda item included in this Notice, with such closed session to be held at the date, hour, and place given in this Notice, concerning any and all subjects, for any and all purposes permitted by V.T.C.A. Government Code Chapter 551, including, but not limited to, private consultation with the District's Attorneys on any or all matters or subjects consider authorized by law, pending or contemplated litigation, personnel matters, real estate transactions, security devices, economic development negotiations and/or gifts and donations.
