Notice is hereby given pursuant to V.T.C.A. Government Code, Chapter 551, that the Board of Directors of Denton County Municipal Utility District No. 16 will meet in **special** session, open to the public, at **12:00 p.m.**, on **Thursday, July 16, 2026**, at **Denton County Country Club, 1213 Country Club Road, Argyle, Texas 76226**; at which meeting the following items will be considered and acted on:

1. Hear from the public;
2. Consider approving minutes of meeting of May 27, 2026;
3. Hear Bookkeeper's Report and authorize payment of bills;
4. Consider adopting proposed budget for the District's fiscal year ending August 31, 2027;
5. Hear Developer's Report;
6. Consider approving an amended Professional Services Agreement with Inframark, LLC;
7. Hear Operator's Report and consider taking any action requested by Operator, including:
 - (a) authorization of repairs to District facilities;
 - (b) authorization of termination of service to delinquent accounts;
 - (c) granting variances to water restrictions;
 - (d) consideration of District usage and billing of water;
8. Hear Engineer's Report and consider taking any action requested by Engineer, including:
 - (a) authorize Engineer to proceed with the design of District facilities;
 - (b) approve plans and specifications of District facilities;
 - (c) authorize Engineer to advertise for bids for District projects;
 - (d) authorize construction contracts and related items;
 - (e) approve report, pay estimates, and change orders for construction projects in progress in the District;
9. Hear Financial Advisor's Report and consider taking any action required;
10. Hear Attorney's Report and consider taking any action required, including:
 - (a) approval of an Application for Approval by the Texas Commission on Environmental Quality of Project and Issuance of Bonds;
 - (b) approval of an Order Authorizing Application for Approval by the Texas Commission on Environmental Quality for Project and Issuance of Bonds;
 - (c) approval of an amendment to the Agreement for Street Lighting Service by and between the District and Oncor Electric Delivery Company LLC for Phase 2, Pod C;
 - (d) approval of a Resolution Evidencing Review of Investment Policy and Investment Strategies;
 - (e) approval of a Resolution Declaring Development Status of the District; and
 - (f) call a public hearing on the proposed 2026 tax rate and authorize distribution of a Notice of Hearing.

Pursuant to V.T.C.A. Government Code, Chapter 551, as amended, the Board of Directors may convene in closed session to receive advice from legal counsel and discuss matters relating to pending or contemplated litigation, personnel matters, gifts and donations, real estate transactions, security devices and/or economic development negotiations.
